Questions:

I. Do you agree with our proposals for those regulatory costs which apply to all providers to be funded by fees?

No

We echo the view of the National Housing Federation in their concern that this proposal is wrong in principle because it transfers the cost burden from general taxation to individual not-for-profit organisations.

As a charity providing a range of different services for older people, our housing association arm is just part of what we do, as we also provide cares homes and community services. This means we already facing the transfer of the costs of the CQC inspection regime, which will be fully funded by providers in the next few years. Recent changes in charity law also mean we are facing new costs for fundraising regulation.

While we recognise the value of independent regulation, it's disappointing that the HCA has chosen this path.
