Description	103 Apartments: 42 x 1 bed apartments 59 x 2 bed apartments 2 x Guest Suites Arranged over three separate cores. Two cores have four floors and one core over five floors, all served by a lift. All apartments are supplied by electricity. There is no gas in the building. Apartments come with a fitted kitchen and are unfurnished.
Status of apartments	The apartments were built in 2010 and are pre-owned
Occupancy	Suitable for one or two people
Tenure	Leasehold 125 years from and including 29th September 2011.
Care provider	Residents can choose a care agency of their choice. MHA does provide personal care with our onsite team dependent on staffing resources at the time. We will endeavour to meet your needs where possible.

Charges when leaving, selling or subletting the property

Contingency Fund contribution

A contribution to the Contingency Fund is payable on sale or a transfer of ownership. The Fund covers spending for the repair or renewal of communal areas, roofs lifts, etc. The contribution is 1% of the 'open market value' at the point of sale/ transfer, for each year or part-year of ownership.

Example: A leaseholder who sells a property owned for five years for £250,000 will have to pay £12,500 calculated as follows:

- 1% of £250,000 = £2,500
- 5 years x £2,500 = £12,500
- Contingency Fund Contribution = £12,500

MHA administration fee for sale

Covers the costs of processing sale documents, dealing with enquiries from solicitors, and signing documents. The fee is at least £499 including VAT.

Other costs

The owner (or the owner's estate) will remain liable for all charges due until the resale has been completed. This includes service charges, wellbeing charges and ground rent charges as applicable.

Owners to redecorate at least once in every seven years and in the event that the property is being sold back to MHA, the owners may need to redecorate otherwise they may be charged for any repairs and redecoration that MHA deems necessary to put the property in good order for them to re-sell.

Owners will have to pay the usual costs associated with any property sale.

Subletting charges

Properties may be sublet in accordance with terms of the lease only to an approved occupier who satisfies the scheme's criteria and only with written approval from MHA.

Sublessees may be required to undergo referencing (and pay a fee for this) prior to approval being given by MHA. The owner will need to pay MHA's legal fees for the sublet and the Contingency Fund contribution and will remain liable for the Service and Wellbeing charges.

Cost of moving in to the property

Asking price	Is set by MHA if the first sale, or sale of a bought-back property. Otherwise this is determined by the private vendor.
Deposit	A reservation fee of £1,000 is payable if purchased from MHA. Agreed between the parties for a private sale.
Other costs	MHA do not charge for a care assessment. The person moving in will be responsible for their own legal and removal costs.

Ongoing charges payable to MHA

Service Charge

The service charge is payable in advance for the month ahead.

This covers communal cleaning and maintenance, external window cleaning, water and sewerage, buildings insurance and estate management. It includes the costs of heating, lighting and water for the communal areas only.

MHA does not receive any incentives from suppliers for services paid for through the service charge.

Cost:

Band A £60.92 per week (1-bed – small, up to 720 sq.ft)

Band B £76.56 per week (1-bed – medium, from 720-1115 sq.ft)

Band B £76.56 per week (2-bed – small, from 719-1000 sq.ft)

Band C £92.20 per week (2-bed – large, 1001-1191 sq.ft)

Band D £101.42 - £132.54 per week (2-bed – duplex)

(Note: Leaseholders are charged on a calendar monthly basis in line with the terms of the lease)

Wellbeing Charge

The Wellbeing Charge is payable in advance for the month ahead.

£59.80 per week
(per apartment)

This includes 24 hour staffing on site, help in an emergency and the co-ordination of an activities and events programme.

(Note: Leaseholders are charged on a calendar monthly basis in line with the terms of the lease)

Emergency Response	<p>Emergency response is covered by the Wellbeing charge.</p> <p>This is not a care service but will provide support in a medical emergency and will co-ordinate calls to GP or emergency services.</p> <p>Any other night care will be included in your care plan(s) and form part of your care agreement(s) and will be charged for separately.</p>	-
Ground Rent	<p>The first Review Date was 31st March 2017, which is then reviewed on this date every fifth year thereafter.</p> <p>Annual ground rent is payable based on the size of the apartment:</p> <p>Cost: £111.30: (1-bed – small: <i>up to 720 sq.ft</i>) £166.95: (1-bed – medium: <i>from 720-1115 sq.ft</i>) £166.95: (2-bed – small: <i>from 719-1000 sq.ft</i>) £222.60: (2-bed – large: <i>from 1001-1191 sq.ft</i>) £278.25: Duplex</p>

Additional MHA Services

Maintenance service	Maintenance carried out within a residents own property. For example: small jobs and repairs	£19.92 per hour (Note: This is chargeable in 15 minute intervals.)
Domestic service charge	This covers the cost of any domestic service that is individual to you and provided by MHA. For example: for housework (vacuuming, dusting, cleaning kitchens/bathrooms etc.)	£16.00 per hour (Note: This is chargeable in 15 minute intervals.)
Laundry service	A laundry service is available onsite.	£14.95 per load
Guest room	There are two guest rooms available.	£35.70 and £41.82 per room

Ongoing costs to external bodies

Utility bills	It is the Residents responsibility to have their own contracts with a Utilities supplier.	
Council tax	It is the Residents responsibility to arrange payment of Council Tax.	-
TV licence	It is the Resident's responsibility to buy their own TV licence. A free licence is available on application to those over 75. If you are blind (severely sight impaired), you are still able to apply for a 50% concession.	£157.50 annual charge
Internet & Telephone provider	Free Wi-Fi is provided in communal areas only. Residents are responsible for arranging their own broadband supplier and arranging their own telephone lines.	-

Insurance arrangements

Responsibility of the operator (MHA)	Communal Buildings Insurance, Public Liability and Employers' Liability are included in the service charge.
Responsibility of the owner	Home contents insurance is strongly recommended. Leaseholders can select their own provider. There is an option of taking insurance out through MHA. The Manager can provide more information.

Understanding the Contingency Fund

What is the Contingency Fund?

This is funded from deferred fees (see above) and covers spending for the repair or renewal of communal areas, roofs lifts, etc., identified from stock condition surveys.

Restrictions

Restrictions on selling the property

Purchasers must satisfy the scheme's criteria (including age and support needs). The Manager will assess this prior to purchase. If an individual has personal care needs, these will be assessed prior to purchase to ensure these can be met either by MHA or a care agency chosen by the purchaser.

MHA has an option to buy back the property if we choose to. If we do buy back the property, we will do so at 95% of the open market value as determined by an independent valuer.
